KINDERGARTEN REGISTRATION 2024-2025

***In order to be eligible to attend Kindergarten in September 2024, your child must be five years old <u>ON</u> or <u>BEFORE</u> October 1, 2024. (No exceptions)

<u>PRE</u>-REGISTRATION BEGINS ON APRIL 8, 2024

Monday, April 8, 2024 the *pre-registration* process will open online <u>www.piscatawayschools.org</u>. Under the "Quick Links" in the gray column, scroll down and click on Enrollment. Click on the application link for Grade K – 2024-2025 school year and complete.

**PLEASE NOTE – If you complete this process <u>before</u> April 8, 2024, your pre-registration will be deleted from our system accordingly, and you will have to complete the process again when it officially opens on April 8, 2024.

REGISTRATION BEGINS ON APRIL 15, 2024

Monday, **April 15**, **2024**, all families that have completed the pre-registration online will receive further communication on how to complete the registration for your child.

You will have the option to complete the registration <u>*virtually*</u>, or you can schedule an <u>*in-person*</u> <u>*appointment*</u>.

We will begin our in-person appointment schedule on May 6, 2024.

**PLEASE NOTE – NO WALK-INS will be permitted due to time constraints. You <u>must</u> have an appointment to complete the registration in-person.

*****REQUIRED FOR ALL REGISTRANTS*****

- <u>HOME OWNERS:</u> Current Property Tax/Sewer Bill OR Deed
- <u>RENTERS:</u> Current Lease (**IF YOUR LEASE EXPIRES BEFORE THE START OF THE SCHOOL YEAR, YOU WILL BE REQUIRED TO SUBMIT A NEW ONE BEFORE YOUR CHILD IS PERMITTED TO START SCHOOL)

THE FOLLOWING DOCUMENTS ARE IN ADDITION TO THE ABOVE

- Student's ORIGINAL birth certificate and/or passport NO EXCEPTIONS
- Immunization records (must be in English and on physician's letterhead)
- Copy of child's latest physical
- Photo ID (of parent) driver's license, passport, work ID, county ID, etc. *If the ID has the <u>current</u> Piscataway address it will also count as one residency item
- <u>At least</u> THREE (3) additional residency items, which include the parent's name and reflect the <u>curren</u>t Piscataway address such as: PSE&G bill, cable bill, phone bill, bank statement, paycheck stub, credit card statement, state agency documents, etc.
- All bills/statements MUST be dated within 30 days, name, date and address must all be visible -PICTURES OF ENVELOPES, ADVERTISEMENTS/FLYERS, OR PERSONAL LETTERS <u>WILL NOT</u> BE ACCEPTED
- Proof of custody (if parents are not living together)
